2017 European Commission Work Programme

Delivering a Europe that protects, empowers and defends

On 25 October 2016, the European Commission adopted its Work Programme for 2017, setting out the key actions that it intends to take over the next twelve months. The third annual Work Programme presented by the Juncker Commission focuses on delivery of the ten priorities outlined in its Political Guidelines, and is the first programme adopted following consultations with the European Parliament (EP) and the Council. Also for the first time, the Commission will now work with the EP and Council to reach an agreement between the three Presidents on a Joint Declaration to be signed in December.

The Commission's 'to do list' consists of a political Communication and five annexes.

- ♦ Annex I lists the 21 new initiatives, which the Commission commits to presenting in 2017. It also includes the REFIT actions, directly related to these key initiatives, to review the quality of existing EU legislation and check if they are fit for purpose. The new initiatives of our interest are:
 - ⇒ Implementation of the Action Plan on Circular Economy;
 - ⇒ Implementation of the Digital Single Market Strategy;
 - ⇒ Implementation of the Energy Union Strategy: low-emission travel and mobility;
 - ⇒ Implementation of the Single Market Strategy;
 - ⇒ Implementation of the Trade for All Strategy;
 - ⇒ Data Protection Package.
- ♦ Annex II lists 18 new REFIT initiatives foreseen for adoption in 2017. It complements the items listed with new initiatives in Annex I. In identifying REFIT priorities, the Commission has taken into account the Opinions of the REFIT Platform. The new REFIT actions of our interest are:
 - ⇒ Waste Electrical and Electronic Equipment;
 - ⇒ Road Infrastructure and tunnels safety Revision of Directive 2008/96/EC and Directive 2004/54/EC.
- ♦ <u>Annex III</u> identifies **35 priority pending legislative proposals**, where swift adoption by the EP and Council is needed, according to the Commission. The priority pending proposals of our interest are:
 - ⇒ Circular Economy Package;
 - ⇒ EU Emissions Trading System;
 - ⇒ Vehicle approval and market surveillance;
 - ⇒ Swift ratification of the Comprehensive Economic and Trade Agreement with Canada.
- Annex IV identifies 19 pending legislative proposals, which the Commission intends to withdraw by April 2017 because they are technically outdated or no longer serve their purpose:
 - ⇒ COM/2014/0566; 2014/0262/NLE;
 - ⇒ COM/2007/0872; 2008/0002/COD.
- ♦ Annex V lists **16 pieces of existing legislation**, which the Commission intends to **repeal** because they have become obsolete:
 - ⇒ Council Directive (EEC) No 73/361 of 19 November 1973.

CONFMET 2016, 17th and 18th November 2016

The Portuguese Society of Metrology and RELACRE organized the Metrology Conference CONFMET 2016 with the title "Measurements in a Dynamic World", held on the 17th and 18th November 2016, at PCTA, in the City of Évora (UNESCO World Heritage). The meetings were attended by 150 participants from the National Laboratories of Metrology, Accredited Laboratories, Universities of Lisbon and Porto Academics, and many others, namely, from the Employment and Vocational Training Center of Évora.

There were 25 presentations and 2 invited communications "Mesures dans un monde dynamique" presented by Maguelonne Chambon, Director of Scientific and Technological Research of LNE - Laboratoire National de Métrologie et d'Essais, France and "The international activity of EUROLAB" presented by Álvaro Ribeiro, President of EUROLAB and RELACRE.





On the second day of the conference, a technical visit was made to the Laboratories of the Employment and Vocational Training Center of Évora of the IEFP, where the high level of training practiced by this institution focused on supporting the local aeronautical industry is appreciated.

- ILAC has recently published the revised versions of ILAC R1 and R4 following the successful ballots of the following revised documents: ILAC R1:09/2016 Management of ILAC Documents was published and is available from the Publications section of the ILAC website. This document provides the rules and procedures for the classification and publication of ILAC documents.—ILAC R4:10/2016 Use of the ILAC Logo and Tagline has just recently been published and is also available from the Publications section of the ILAC website. This revision was carried out to include the new tagline that was approved by the ILAC Executive and MCC in April 2016 and was developed for ILAC as an action item under the implementation of the current ILAC Strategic Plan.
- Whilst not an ILAC publication, The Organisation for Economic Cooperation and Development (OECD) has published the
 OECD Position Paper Regarding the Relationship between the OECD Principles of Good Laboratory Practice
 (GLP) and ISO/IEC 17025. The Position Paper, as well as other documents in the OECD Series on principles of
 GLP and compliance monitoring, are publicly available from the OECD website.
- The agenda papers for the Twentieth ILAC General Assembly to be held in New Delhi, India, on Wednesday 2th and Friday 4th November 2016 are available to access via the Meeting Documents page of the conference website. The file sharing area can be accessed from the Meeting Documents page of the conference website at http://ilac.org/conferences/.
- Following the recent IAF and ILAC ballots on the outcome of the joint IAF/ILAC evaluation of EA that have recently closed, that the recommendations as detailed enclosed have been adopted in relation to the recognition of the EA MLA to the IAF MLA and ILAC MRA.
- The revised draft EA-1/14 Procedure for Development and Approval of EA Documents and Adoption of ILAC/IAF Documents, in clean and track changes versions has been circulated among the EA members.
- The EA Certification Committee (EACC) has been revising EA-7/04 M 2007: Legal Compliance as a part of Accredited ISO 14001: 2004 Certification, following the publication of revised ISO 14001:2015 and ISO/IEC 17021-1:2015. The draft has been sent to both EACC Members and EA General Assembly as revised by the EACC WG Environment for a joint 60-day commenting period.
- The List of Conclusions and Resolutions agreed at the EAAB Meeting on 12 October 2016 has been made available on the EAAB intranet.
- The approved Resolutions of the 38th EA General Assembly have been published and are available on the EA intranet.
- The EA Certification Committee (EACC) has been revising EA-7/04 M 2007: Legal Compliance as a part of Accredited ISO 14001: 2004 Certification, following the publication of revised ISO 14001:2015 and ISO/IEC 17021-1:2015. The draft has been sent to both EACC Members and EA General Assembly as revised by the EACC WG Environment for a joint 60-day commenting period.
- The resolutions from the **IAF General Assembly** held on the 4th of November and the JGA resolutions have been posted on the IAF website.
- IAF has issued a call for nominations for the IAF Quality Manager position. Mr. Pedro Alves was appointed as IAF Quality Manager by the IAF Board in April 2014, and will thus complete his first three-year term in April 2017. Mr. Alves has agreed to stand for a second and final three-year term; however, in accordance with IAF practice, it is necessary to call for nominations from all IAF Members. Nominations are therefore invited for the IAF Quality Manager position for a three-year term beginning in May 2017.
- Following the success of the <u>Public Sector Assurance website</u> developed by ILAC IAF, IEC, IIOC, ILAC, ISO, which provides access to over 200 practical case studies and 70 research papers to demonstrate the value of standards and accreditation for the public sector, the ILAC MCC / IAF CMC are seeking ways to collect and share data that show the benefit of standards and accredited conformity assessment to businesses.

The ballot was approved by the members.

- A three-month DIS ballot on ISO/IEC 17025, General requirements for the competence of testing and calibration laboratories, will open on 2016-12-29 and close on 2017-03-22.
- IEC/TC 123 on Standardization of the management of assets in power systems has been created as Active on the ISO Global Directory.
- ISO/CASCO and the Technical Management Board (TMB) are organizing a workshop on service standards in Vancouver on 28 April 2017. This workshop is going to be held in conjunction with the CASCO 32nd plenary meetings.

- The CIB (Committee Internal Ballot) SC17 N440 NWIP from SC7 guidelines for saffron including WD (Working Draft)
 was closed. Members voted in favour of the ballot.
- The appointment of the **next chairman of ISO/TC 135/SC 2** (Surface methods) which was put on CIB (ISO/TC 135 N521 with amendment of N525) has been approved. The term of office of the new SC 2 chairman, Mr Dion Agostinho, is from January 2017 to December 2019.

- Core Informatics has announced a new validated cloud infrastructure offering, built on Amazon Web Services (AWS), for regulated and GxP customers across industries. The validated cloud infrastructure enables regulated laboratories to experience the cost, scalability, and reliability benefits of AWS's industry-leading cloud infrastructure. The validated cloud infrastructure offering was designed and built by Core Informatics, and runs on the AWS Cloud.
- Core Laboratories N.V. (NYSE: "CLB US")(Euronext Amsterdam: "CLB NA") repurchased a total of 16,000 of its common shares at an average price stated in USD of \$112.79 per share. These repurchases were made as part of the Company's existing share repurchase program.
- DEKRA subsidiary AT4 wireless has been appointed as the first accredited test laboratory in North America by the LoRa Alliance. At its laboratories in Herndon (Virginia, USA) and Málaga (Spain), DEKRA now provides testing services in North America and Europe for products under the LoRaWAN certification program.
- In Shanghai (Jiading), DEKRA has opened a new laboratory for testing automotive components and materials. The focus is the growing demand for safe wireless components for the Internet of Vehicles (IoV) and safe electromobility.
- DEKRA will test and certify the innovative Laser Coating Removal (LCR) robot for LR Systems BV. The robot, developed by LR Systems, will deploy a 20kW laser to remove paint from any size commercial and military aircraft with the greatest precision. In addition, the robot allows a faster and cleaner removal process than contemporary methods and contributes to a significantly reduced aircraft ground time.
- DNV GL launched industry's first technology qualification scheme to assure accuracy of gas flow metering in field conditions.
- Hamburg-based Eppendorf AG have acquired Calibration Technology Ltd, headquartered in the National Technology Park Limerick, Ireland.
- Huawei had its new HUAWEI FIT model MES-B19 tested according to the TÜV SÜD standard and was awarded the Wearables certification mark.
- Intertek has announced the further expansion of chemical regulatory services in the United States with the expansion of its Health, Environmental and Regulatory Services (HERS) department in the District of Columbia to address companies' needs resulting from the recently signed Toxic Substances Control Act (TSCA) reform.
- Intertek is working with Elekta, a company in the use of radiotherapy and radiosurgery, on new research technology which combines a linear accelerator and MR imaging, enabling imaging while irradiating, for use in the treatment of cancer.
- Intertek has announced the further expansion of its sustainability services through a partnership with Environmental Packaging International (EPI), developer of redipoint®, a global Extended Producer Responsibility (EPR) reporting solution.
- Intertek has collaborated with OCSiAl's Health and Safety Department and its European service provider, Envigo, to prove that TUBALL™ single wall carbon nanotubes fully comply with EU REACH requirements. Intertek was contracted by OCSiAl to work with the European Chemicals Agency (ECHA) to provide the required chemical safety data and reports. Intertek scientific and regulatory experts were ultimately

- responsible for the preparation of the robust REACH registration dossier and the coordination of the physchem, tox, and ecotox testing done with Envigo.
- TÜV India in association with GIZ organized Best Practices Forum on Food Safety and Regulations to successfully conclude the project which was initiat-ed to improve food safety hygiene and product quality in the Indian food processing sector.
- New Mexico-based TriCore Reference Laboratories has inked an agreement with iSpecimen, a Boston company that connects medical researchers with appropriate specimens from laboratories and hospitals.
- For years, TÜV SÜD ELAB, has offered food, water and environmental analyses and medical laboratory services. The company has now developed a test scheme for the food sector. Under this voluntary scheme, companies can have the quality of their prod-ucts tested at regular intervals by a third party and can proactively communicate their commitment to quality.
- TÜV SÜD announces services for medical device manufacturing, ahead of crucial revision of EU's Medical Device Regulations (MDR). The services will help equipment manufacturers' transition into the revised manufacturing guidelines.
- UL officially opened its new Consumer and Retail Services (CRS) Testing Laboratory in Ho Chi Minh City, Vietnam. The state of the art laboratory spans over 1,300 square meters and expands capacity in the region to test toys and premiums, textiles, footwear, accessories and jewelry for compliance with a variety of safety and performance-related requirements
- UL and QUATEST3 (Quality Assurance and Testing Center 3) have announced the signing of an Alliance Agreement to develop a furniture and chemical emissions testing laboratory in Vietnam. The goal of the agreement is to provide a world-class product testing facility and expertise in regulations that will enable Vietnamese furniture manufacturers to expand teir business into global markets.
- SGS has joined the Zero Discharge of Hazardous Chemicals (ZDHC) Program and in doing so, supports the Program's vision of widespread implementation of sustainable chemistry and best practices in the textile and footwear industries to protect consumers, workers and the environment.
- A Memorandum of Understanding was signed between SGS and the Ukrainian Grain Association, uniting the Ukrainian and international grain companies, and one of the organizations in the grain business. This Memorandum of Understanding provides a framework for cooperation between both parties in the field of agriculture, including production, processing, inspection, verification, testing and certification, trade, exchange of information and technologies.
- with the intention of promoting Food Safety standards in India, SGS along with Mettler Toledo, a manufacturer of precision instruments and services for use in laboratories and manufacturing, partnered with BRC Global Standards, to promote their new Food Safety Standards.
- Seed and crop growers across Brazil can now benefit from the agriculture services of SGS, following the company's recent acquisition of a 75% stake in Unigeo.

Policy news

Chemicals

European Chemicals Agency (ECHA) completed toolkit for REACH 2018 registration. The last REACH
registration deadline will be on 31 May 2018. This deadline concerns companies that manufacture or import chemical substances in low volumes, between 1-100 tonnes per year.

Consumer Protection

- European and national policy makers, researchers and industry experts have met at the 2016 European
 Consumer Summit in Brussels to discuss how EU consumer and marketing legislation can be streamlined. Commissioner Jourová have given the keynote speech about consumer information requirements,
 fairness of commercial practices and terms as well as better enforcement of EU consumer law. Participants have
 discussed the topics in further detail in several workshops and case studies.
- The leading legal affairs committee in the European Parliament has cleared a draft law which would allow consumers to use their home online subscriptions for games, video streaming or music when travelling in another EU Member State. Currently, many restrictions to use subscriptions abroad exist. Following this vote, MEPs and EU governments will start negotiations to agree to a final text. http://tinyurl.com/hebyeb3
- The European Parliament's Committee on Internal Market and Consumer Protection (IMCO) exchanged views on the proposed regulation that will establish a programme running for the period 2017-2020 with an overall maximum budget of EUR 6 000 000 to support the activities carried out by Finance Watch and Better Finance. The programme builds on a pilot project (2012-2013) and preparatory action (2014-2016) that was aiming to provide grants to consumer bodies and civil society organisations lacking the adequate funds to conduct research on highly technical topics to the benefit of endusers and non-industry stakeholders.
- The European Commission proposed new rules for consumer centred clean energy transition with the package of measures to keep the European Union competitive as the clean energy transition is changing global energy markets. The Commission wants the EU to lead the clean energy transition, not only adapt to it. For this reason the EU has committed to cut CO2 emissions by at least 40% by 2030 while modernising the EU's economy and delivering on jobs and growth for all European citizens.
- EU ministers agreed on plans to make it easier for consumers to buy products online from shops located in other Member States. Following the publication of a proposal in May of this year to stop geo-blocking, EU governments and the European Parliament are now deciding on what amendments they want to put forward. Geo-blocking is a common practice under which retailers refuse to sell goods and services to people living in other EU countries. http://tinyurl.com/zslvmb4

Energy & Environment

- First Vice-President Frans Timmermans and Vice-President Jyrki Katainen has set out the Commission's new approach on ecodesign. President Juncker had proposed a new approach with full political ownership of the Commissioners for new decisions in this field. http://tinyurl.com/zqz7uow
- The European Parliament has approved the ratification of the Paris Agreement by the European Union. With European Parliament approval of the Paris Agreement ratification in the presence of European Commission President Jean-Claude Juncker, the United Nation's Secretary General Ban Ki-moon and the President of COP 21 Ségolène Royal the last hurdle is cleared. The political process for the European Union to ratify the Agreement is now concluded. https://tinyurl.com/gqednic
- Following the European Parliament's ratification and the entry into force of the 2015 Paris agreement, a 12-Member delegation took part in UN (COP22) climate talked in Marrakesh. The focus of this week's round of talks was on the implementation of the Paris agreement. Delegates worked on making national climate plans as clear and transparent as possible, and on ensuring that the actions taken are traceable and that standardised reporting methods are used. There was also be discussions on enhanced action prior to 2020.
- The European Parliament's Committee on Environment, Public Health and Food Safety (ENVI) has published a <u>study</u> entitled "Implementing the Paris Agreement COP 22 Climate Change Conference in Marrakesh".
- The European Parliament's inquiry committee into emission measurements in the car industry (EMIS) has continued its work by hearing Alexander Dobrindt, the German Federal Minister of Transport and Olaf Lies, Lower Saxony's State Minister for the Economy, Labour and Transport.

- The European Parliament endorsed the deal to revise the National Emissions Ceilings Directive (NECD). The revision will encompass emission reductions for SO2, NOx, NMVOC, NH3 and PM2.5 for 2020 and 2030. The national emission limits for 2020 remain the same as those in the Gothenburg Protocol, such as a reduction in NOx emissions in the UK by 55% (against 2005 base level) by 2020. But the revised NECD sets additional targets for 2030, including a 73% reduction in NOx.
- The European Commission in its press release called the EU countries to reduce consumption of lightweight plastic carrier bags. The report indicates that EU governments have until 27 November 2016 to adopt measures to cut the consumption of lightweight plastic carrier bags, and inform the European Commission about it which is required by the EU Plastic Bags Directive.
- The European Commission has approved an investment package of €222.7 million from the EU budget to support Europe's transition to a more sustainable and low-carbon future. The EU funding will spur additional investments leading to a total of €398.6 million to be invested into 144 new projects in 23 Member States. http://tinyurl.com/zs5jdnh
- European Commission Vice-President for Energy
 Union Maroš Šefčovič and Energy Minister of
 Ukraine, Ihor Nasalyk, signed a new Memorandum
 of Understanding on a Strategic Energy Partnership between the EU and Ukraine. The Memorandum of Understanding aims to invigorate energy cooperation between the EU and Ukraine. http://tinyurl.com/zms72ag
- The European Commission has released a set of proposals on a new rule book for the EU energy market. The proposed reform will enable a clean energy transition to take place, at the best value for consumers. The rules will allow the energy

- Morocco, Germany, France, Spain and Portugal have signed a roadmap for sustainable electricity trade, in the presence of European Commissioner for Climate Action and Energy, Miguel Arias Cañete. The College agreed, on the proposal of President Juncker, to take a package-based approach going forward and to ensure that the Commission works in particular on those products where there is a clear benefit for European consumers in terms of energy and cost savings, job creation and revenue benefits for European industry, and energy or resource efficiency which contributes to the fight

Medical Devices

- Following the political agreement on Medical Devices and on In Vitro Diagnostic Medical Devices proposals, the two draft Regulations will now be subject to legal-linguistic finalisation. The finalised texts will be submitted to the Council for formal adoption as its position at first reading. They will subsequently be transmitted to the European Parliament together with the Council's Statements of Reasons.
- The German delegation, supported by the Austrian delegation, has submitted the statement concerning the German language version of the proposals on Medical Devices and on In Vitro Diagnostic Medical Devices. It was stated that the German-language version requires considerable improvement in order to bring it in line with the English-language version. The French, Italian, Polish, Portuguese and Slovenian delegations have expressed similar concerns regarding their respective language versions.
- Medical technologies regroup at EU level into one single representation: MedTech Europe. The members of EDMA (the European Diagnostic Manufacturers Association) and Eucomed (the European Medical Device Manufacturers Association) have voted to dissolve their respective European associations. A new MedTech Europe single entity has been created, representing the European medical technology sector, from diagnosis to cure. As a consequence, EDMA and Eucomed no longer exist.
- On 14 November 2016, the French National Agency for Medicines and Health Products Safety ("ANSM") issued the English version of an information bulletin and a Q&A document concerning the consequences of de-notification or termination of notified bodies' ("NB") activities, dated 24 October 2016. The issue of the de-notification of notified bodies was raised at a meeting of the competent authorities of the EU Member States on 19 October 2016. At this meeting, competent authorities agreed on guidelines for managing such situations. In the information bulletin the ANSM announced that, in line with these guidelines, it had established procedures for medical device manufacturers affected by the de-notification of a notified body and established in France. http://tinyurl.com/heaaqn3

International Free Trade Agreements

- The EU and Canada have signed the Comprehensive Economic and Trade Agreement (CETA) and a new Strategic Partnership Agreement that would deepen cooperation in vital areas such as human rights, international peace and security, economic and sustainable development, justice, freedom and security. By removing almost all import duties, CETA will allow European exporters of industrial and agricultural goods to save up to 500 million euros every year. The agreement protects workers' rights, environmental standards and consumer safety. European products with geographical indications will enjoy special status on the Canadian market. Governments will retain all of their powers to legislate, regulate and provide public services. A new public system for resolving disputes brings greater transparency, giving investors confidence that rules will be respected at all times. The system enshrines the right of governments to regulate, including when such regulations affect a foreign investment. http://tinyurl.com/jfxwkt8
- The Council adopted by written procedure a package of decisions on the comprehensive economic and trade agreement with Canada

- (CETA), including: a decision on signature of the agreement; a decision on the provisional application of the agreement; and a decision to request the consent of the European Parliament for the conclusion of the agreement. The representatives of the Member States also adopted a joint interpretative instrument.
